Notice of cancellation received:

- 91 or more days prior to departure, a full refund will be made less a cancellation fee of \$500.00 (deposit) plus funds irrecoverable (i.e. airfare, accommodations, greens fees, ground transportation, sightseeing and attractions etc.)
- 61-90 days prior to departure, \$500.00 (deposit) and 40% of the total land cost is non-refundable, plus funds irrecoverable (i.e. airfare, accommodations, greens fees, ground transportation, sightseeing and attractions etc.)
